NEW BUSINESS:

Ber-National Controls Invoice:

Mr. Schultz presented the BOFC with an invoice from Ber-National for the replacement of two of the new cameras. He went on to state that the invoice indicates that only one camera was covered under warranty on the invoice and believed both should be. The cameras in question developed moisture under the housing glass. When Mr. Schultz questioned Ber-Nationals as to why both weren't covered under the warranty, he was told that the manufacturer does not cover weather related repairs and that Ber-National covered one of the cameras to help us out. Mr. Schultz obtained a copy of the warranty and noted that there was no mention of a weather related exclusion. He further reviewed the original Ber-National proposal that claimed we would be receiving "12 cameras equipped with 2 mega pixel lenses and complete weather proof and vandal proof housing." After a discussion, the BOFC indicated that they will not authorize payment for the replacement cameras and asked Mr. Schultz to convey this back to Ber-National.

A motion was made by Mr. Vander Molen, seconded by Ms. Scicchitano to go into Executive Session to discuss a personnel matter. All Commissioners present voted in the affirmative. Motion approved at 6:37PM.
